**Dr. Christopher W. May** is a freshwater ecologist and environmental engineer with expertise in urban watershed assessment and management. His areas of interest include stormwater management, low impact development (LID), salmonid habitat restoration, urban stream rehabilitation, water quality monitoring, stream biological assessment, and watershed restoration. Currently, he is the Senior Program Director of the Kitsap County Public Works Stormwater Management Program. Prior to joining the KCPW-Stormwater team Dr. May was the head of the Urban Watershed Group at Seattle Public Utilities (SPU), a senior research scientist and engineer at the Battelle Marine Sciences Laboratory (MSL) and, a research engineer at the University of Washington Applied Physics Laboratory (UW-APL); his research there centered on the cumulative impacts of urbanization on native salmonids in small streams in the Puget Sound lowland eco-region. Dr. May is an adjunct faculty member of Western Washington University Huxley College of the Environment, and the University of Washington Environmental Science Program.
