### **3:10 – 3:30 Review/Discussion: revised Logic Model**

- The group agrees upon the revised Outcomes

### **3:30 - 3:50 Review/Discussion: Metrics**

- Metrics must come from a valid source and be regularly collected (consistent inconsistencies accepted)
- Regarding the metric of percent of children eligible for free & reduced lunch, we want the participation rate v. eligibility, broken down by school
- Regarding meals provided through summer meal program, we need # of sites & percent of eligible youth during the school year vs. those who participate during summer meal programs
- Are there ways to organize ourselves locally, on the ground so we can compare and see how we're doing (are we turning the dial?) vs. hard data
- What other kind of things are there out there? These metrics start us thinking what kind of metrics we want to look at, and are they valid and reliable?
- Important to keep in mind that not everything important is measurable. How would you measure family self-sufficiency in food? For this reason we should use the metrics to keep us on track, but not something we must follow religiously
- No decision based on metrics made today. we will narrow this list of metrics to about 5-8, and from there focus in on these

- What can we actually influence from our Outcomes?
